DECLARATION OF COMMITMENT FOR COOPERATION IN AIRSPACE DEVELOPMENT

BETWEEN THE GOVERNMENTS OF DENMARK, ESTONIA, FINLAND, LATVIA, NORWAY AND SWEDEN

Having regard to:

- the goals of the Single European Sky initiative, which implies defragmenting the European airspace, reducing delays, increasing safety standards and flight efficiency to reduce the aviation environmental footprint and reducing costs related to service provision;
- the European Commission White Paper 2011: "Roadmap to a Single European Transport Area" – while respecting the different international obligations of each State; and

Recognizing:

- the on-going formalised cooperation between the North European Functional Airspace Block (NEFAB) and the Danish-Swedish FAB at National Supervisory Authority (NSA) and Air Navigation Service Provider (ANSP) level, and
- the call from Vice-President of the European Commission, Siim Kallas, for a binding political commitment by the States participating in the Danish-Swedish FAB and NEFAB respectively,

the Ministers responsible for transport of Denmark, Estonia, Finland, Latvia, Norway and Sweden confirm their commitment for a continued cooperation in enhancing the functionality in their airspace.

The Ministers are committed to closer cooperation at FAB level between NEFAB and the Danish-Swedish FAB. The aim is a possible future consolidation of the two FABs when a comparable level of ambition regarding the achievements to be realised through a FAB cooperation is reached, inter alia harmonisation of operational concepts, performance of the ANSPs and related cost-efficiency.

As a first step, the six States commit themselves to undertake necessary actions to ensure implementing the Free Route Airspace concept, above FL 285, in the entire airspace of NEFAB and Danish-Swedish FAB by the end of year 2015.

The enhanced cooperation will be facilitated and monitored by a network of representatives at Ministerial level from each of the signing states.

Furthermore, the Ministers are committed to encourage their air navigation service providers in NEFAB and the Danish-Swedish FAB to cooperate in achieving synergies and economies of scale related to the provision of Air Traffic Services across national borders between the NEFAB States and Denmark/Sweden.
